I am pleased to advise that at its meeting on 20th December 2017, the Board Accreditation Committee of the International Society for Quality in Health Care, endorsed the recommendation of the ISQua Accreditation Council for the Accreditation of the 2017 Laboratory Standards of the Laboratory Medicine Foundation of Korea (LMF).

Accreditation of the 2017 Laboratory Standards is from 2017 through to 2021.
